



## QUALIFICATIONS

Before the filing officer accepts any declaration of candidacy, the filing officer shall read to the candidate the constitutional and statutory requirements for candidacy, and the candidate shall state whether he/she fulfills the requirements. If the candidate indicates that he/she does not qualify, the filing officer shall decline his/her declaration of candidacy. (Utah Code Section 20A-9-201, 202)

*Utah Constitution Article VIII, Section 7, 9; UCA 20A-12-201*

- U.S. citizen
- At least 25 years of age
- Admitted to the practice of law in Utah
- Resident of Utah for at least 3 years preceding selection
- Non-partisan, unopposed retention election
- Pay a filing fee of \$50.00

### JUSTICE COURT JUDGE

*Utah Constitution, Article VIII, Section 11; Utah Code Section 78A-7-201*

- Citizen of the United States;
- 25 years of age or older;
- Resident of Utah for at least three years immediately preceding his appointment;
- Resident of the county in which the court is located or an adjacent county for at least six months immediately preceding appointment;
- Qualified voter\* of the county in which the judge resides;
- Have at least a diploma of graduation from high school or its equivalent;
- Person who has demonstrated maturity of judgment, integrity, and the ability to understand and apply appropriate law with impartiality.
- Non-partisan, unopposed retention election
- Pay a filing fee of \$25.00 per office.

#### \*Qualified Voter:

1) is a citizen of the United States; 2) is a resident of Utah; 3) will, on the date of that election: be at least 18 years old and have been a resident of Utah for 30 days immediately before that election; 4) and has registered to vote.
