
## NOTICE OF ELECTION

### 2016 REGULAR GENERAL ELECTION

I, Spencer J. Cox, Lieutenant Governor of the State of Utah, in accordance with Utah Code Section 20A-5-101, do hereby notify each County Clerk that:

1. attached is a list of the offices to be filled at the regular general election to be held in the State of Utah on Tuesday, November 8, 2016;
2. attached is the Master Ballot Position List and written procedures for election officials to use the List;
3. attached is a list of filing fees, and;
4. the Declaration of Candidacy filing period for qualified political party candidates begins on Friday, March 11, 2016 and ends at 5:00 p.m., Thursday, March 17, 2016, and;
5. the Declaration of Candidacy filing period for state and local school board candidates begins on Monday, January 4, 2016 and ends at 5:00 p.m., Thursday, March 17, 2016, and;
6. the Declaration of Candidacy filing period for justices and judges of a court of record begins Friday, April 1, 2016 and ends at 5:00 p.m., Friday, April 15, 2016, and;
7. the Declaration of Intent to Gather Signatures period for qualified political party candidates begins on Monday, January 4, 2016 and ends at 5:00 p.m., Thursday, March 17, 2016, and;
8. candidates must submit nomination petition signatures no later than 14 days before the day on which the qualified political party holds its convention to select candidates for the elective office.

## 1. FEDERAL

- a. **U.S. President and Vice President.** These positions will be elected for a four (4) year term.
- b. **U.S. Senate.** One Senator for a six (6) year term.
- c. **U.S. House of Representatives.** One Representative for a two (2) year term in each of the following U.S. Congressional Districts:
  - i. **First District.** The First Congressional District consists of Box Elder, Cache, Daggett, part of Davis, Duchesne, Morgan, Rich, Summit, Uintah, and Weber Counties.
  - ii. **Second District.** The Second Congressional District consists of Beaver, part of Davis, Garfield, Iron, part of Juab, Kane, Millard, Piute, part of Salt Lake, part of Sanpete, Sevier, Tooele, Washington, and Wayne Counties.
  - iii. **Third District.** The Third Congressional District consists of Carbon, Emery, Grand, part of Salt Lake, San Juan, part of Utah, and Wasatch Counties.
  - iv. **Fourth District.** The Fourth Congressional District consists of part of Juab, part of Salt Lake, part of Sanpete, and part of Utah Counties.

## 2. STATE

- a. **State Executive.** The following positions will be elected for a four (4) year term:
  - i. Attorney General.
  - ii. Auditor.
  - iii. Governor.
  - iv. Lieutenant Governor.
  - v. Treasurer.
- b. **State Senate.** One member for a four (4) year term from each of the following state senate districts:
  - i. District One (1) is located in Salt Lake County.
  - ii. District Six (6) is located in Salt Lake County.

- iii. District Seven (7) is located in Utah County.
  - iv. District Eight (8) is located in Salt Lake County.
  - v. District Ten (10) is located in Salt Lake County.
  - vi. District Thirteen (13) is located in Salt Lake and Utah Counties.
  - vii. District Fourteen (14) is located in Utah County.
  - viii. District Sixteen (16) is located in Utah and Wasatch Counties.
  - ix. District Nineteen (19) is located in Morgan, Summit, and Weber Counties.
  - x. District Twenty (20) is located in Davis and Weber Counties.
  - xi. District Twenty-three (23) is located in Davis and Salt Lake Counties.
  - xii. District Twenty-four (24) is located in Beaver, Garfield, Juab, Kane, Millard, Piute, Sanpete, Sevier, Utah, and Wayne Counties.
  - xiii. District Twenty-five (25) is located in Cache and Rich Counties.
  - xiv. District Twenty-seven (27) is located in Carbon, Emery, Grand, San Juan, Utah, and Wasatch Counties.
  - xv. District Twenty-nine (29) is located in Washington County.
- c. **State House of Representatives.** One member of the Utah House of Representatives for a two (2) year term from each of the seventy-five (75) state legislative districts.
- d. **State Board of Education.** One member for a four (4) year term from each of the following State School Districts: 4, 7, 8, 10, 11, 12, 13, and 15.
- i. District Four (4) is located in Davis and Weber Counties.
  - ii. District Seven (7) is located in Salt Lake and Summit Counties.
  - iii. District Eight (8) is located in Salt Lake County.
  - iv. District Ten (10) is located in Salt Lake County.

- v. District Eleven (11) is located in Salt Lake and Utah Counties.
- vi. District Twelve (12) is located in Daggett, Duchesne, Summit, Uintah, Utah, and Wasatch Counties.
- vii. District Thirteen (13) is located in Utah County.
- viii. District Fifteen (15) is located in Iron and Washington Counties.

e. **Local Boards of Education.** Members of the local boards of education should be elected as determined by individual school boards or districts.

### 3. JUDICIAL

- a. **District Court.** There will be a retention election for twenty-one (21) District Court Judges in the following districts, provided that the incumbent(s) whose term is expiring files during the filing period:
  - i. First District. One (1) Judge in the First Judicial District, which consists of Box Elder, Cache, and Rich Counties.
  - ii. Second District. Three (3) Judges in the Second Judicial District, which consists of Davis, Morgan, and Weber Counties.
  - iii. Third District. Nine (9) Judges in the Third Judicial District, which consists of Salt Lake, Summit, and Tooele Counties.
  - iv. Fourth District. Four (4) Judges in the Fourth Judicial District, which consists of Juab, Millard, Utah, and Wasatch Counties.
  - v. Fifth District. One (1) Judge in the Fifth Judicial District, which consists of Beaver, Iron, and Washington Counties.
  - vi. Seventh District. Two (2) Judges in the Seventh Judicial District, which consists of Carbon, Emery, Grand and San Juan Counties.
  - vii. Eighth District. One (1) Judge in the Eighth Judicial District, which consists of Daggett, Duchesne, and Uintah Counties.
  
- b. **Juvenile Court.** There will be a retention election for eleven (11) Juvenile Court Judges in the following districts, provided that the incumbent(s) whose term is expiring files during the filing period:

- i. Second District. One (1) Judge in the Second Judicial District, which consists of Davis, Morgan, and Weber Counties.
- ii. Third District. Four (4) Judges in the Third Judicial District, which consists of Salt Lake, Summit, and Tooele Counties.
- iii. Fourth District. Two (2) Judges in the Fourth Judicial District, which consists of Juab, Millard, Utah, and Wasatch Counties.
- iv. Fifth District. One (1) Judge in the Fifth Judicial District, which consists of Beaver, Iron, and Washington Counties.
- v. Sixth District. One (1) Judge in the Sixth Judicial District, which consists of Garfield, Kane, Piute, Sanpete, Sevier, and Wayne Counties.
- vi. Eighth District. Two (2) Judges in the Eighth Judicial District, which consists of Daggett, Duchesne, and Uintah Counties.

- c. **Justice Court.** Any Justice Court judge whose term is expiring shall be subject to an unopposed retention election in the county or counties in which the court to which the judge is appointed is located.

#### **4. COUNTY**

County offices up for election are to be determined by the county's form of government.

#### **6. MASTER BALLOT POSITION LIST, RANDOM SELECTION, PROCEDURES**

In accordance with Utah Code Section 20A-6-305, Utah Lieutenant Governor Spencer J. Cox hereby establishes the Master Ballot Position List, establishes written procedures for election officials to use the Master Ballot Position List, establishes written procedures for the Lieutenant Governor in conducting the randomization in a fair manner, and provides a record of the random selection process used.

**b. Written procedures for election officials to use the master ballot position list.**

In accordance with Utah Code Section 20A-6-305, election officers shall use the master ballot position list for 2016-2017 to determine the order in which to list candidates on the ballot for any election held during those years.

To determine the order in which to list candidates on the ballot, the election officer shall apply the randomized alphabet using: the candidate's surname; for candidates with a surname that has the same spelling, the candidate's given name; if the ballot provides for a ticket or a straight party ticket, the name of the registered political party. This does not apply to an election for an office for which only one candidate is listed on the ballot or a judicial retention election under Section 20A-12-201.

**c. Written procedures for the Lieutenant Governor in conducting the randomization in a fair manner and record of the random selection process used.**

In accordance with Utah Code Section 20A-6-305, the Lieutenant Governor's Office conducted the randomization process by using a random alphabet generator utility in the statewide voter database application VISTA (voter information & state tracking application). The randomization was done on Monday, November 16, 2015 in the presence of witnesses representing political parties in Utah.
