



As per UCA §20A-9-403, the Lt. Governor's office certifies the numbers below are the signature requirements for Qualified Political Party candidates for the 2016 election cycle. As of November 16, 2015, each political party in Utah is classified as a Qualified Political Party.

Candidates may only collect signatures from voters who are eligible to vote in the party's primary election.
