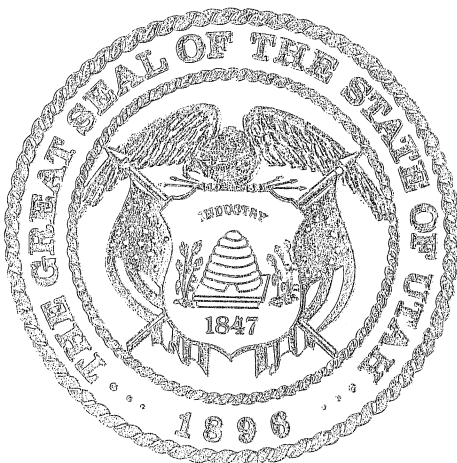

NOTICE OF ELECTION 2018 REGULAR GENERAL ELECTION

I, Spencer J. Cox, Lieutenant Governor of the State of Utah, in accordance with Utah Code Annotated §20A-5-101, do hereby notify each County Clerk that:

1. attached is a list of the offices to be filled at the regular general election to be held in the State of Utah on Tuesday, November 6, 2018;
2. attached is a list of filing fees, and;
3. the Declaration of Candidacy filing period for qualified political party candidates and local school board candidates begins on Friday, March 9, 2018 and ends at 5:00 p.m., Thursday, March 15, 2018, and;
4. the Declaration of Candidacy filing period for justices and judges of a court of record begins Monday, July 2, 2018 and ends at 5:00 p.m., Monday, July 16, 2018, and;
5. the Declaration of Intent to Gather Signatures period for qualified political party candidates begins on Tuesday, January 2, 2018 and ends on Thursday, March 15, 2018, and;
6. candidates must submit nomination petition signatures no later than 14 days before the day on which the qualified political party holds its convention to select candidates for the elective office.

1. FEDERAL

- a. **U.S. Senate.** One (1) Senator for a six (6) year term.
- b. **U.S. House of Representatives.** One (1) Representative for a two (2) year term in each of the following U.S. Congressional Districts:
 - i. First District, which consists of Box Elder, Cache, Daggett, part of Davis, Duchesne, Morgan, Rich, Summit, Uintah, and Weber Counties.
 - ii. Second District, which consists of Beaver, part of Davis, Garfield, Iron, part of Juab, Kane, Millard, Piute, part of Salt Lake, part of Sanpete, Sevier, Tooele, Washington, and Wayne Counties.
 - iii. Third District, which consists of Carbon, Emery, Grand, part of Salt Lake, San Juan, part of Utah, and Wasatch Counties.
 - iv. Fourth District, which consists of part of Juab, part of Salt Lake, part of Sanpete, and part of Utah Counties.

2. STATE

- a. **State Senate.** One (1) member for a four (4) year term from each of the following state senate districts:
 - i. District Two (2), located in Salt Lake County.
 - ii. District Three (3), located in Salt Lake County.
 - iii. District Four (4), located in Salt Lake County.
 - iv. District Five (5), located in Salt Lake County.
 - v. District Nine (9), located in Salt Lake County.
 - vi. District Eleven (11), located in Salt Lake and Utah Counties.
 - vii. District Twelve (12), located in Salt Lake and Tooele Counties.
 - viii. District Fifteen (15), located in Utah County.
 - ix. District Seventeen (17), located in Box Elder, Cache, and Tooele Counties.

- x. District Eighteen (18), located in Davis, Morgan, and Weber Counties.
 - xi. District Twenty-one (21), located in Davis County.
 - xii. District Twenty-two (22), located in Davis County.
 - xiii. District Twenty-six (26), located in Daggett, Duchesne, Summit, Uintah, and Wasatch Counties.
 - xiv. District Twenty-eight (28), located in Beaver, Iron, and Washington Counties.
- b. **State House of Representatives.** One (1) member of the Utah House of Representatives for a two (2) year term from each of the seventy-five (75) state legislative districts.
- c. **State Board of Education.** One (1) member for a four (4) year term from each of the following State School Districts:
- i. District One (1), located in Box Elder, Cache, Morgan, Rich, and Weber Counties.
 - ii. District Two (2), located in Weber County.
 - iii. District Three (3), located in Juab, Salt Lake, and Tooele Counties.
 - iv. District Five (5), located in Davis and Salt Lake Counties.
 - v. District Six (6), located in Salt Lake County.
 - vi. District Nine (9), located in Utah County.
 - vii. District Fourteen (14), located in Beaver, Carbon, Emery, Garfield, Grand, Kane, Millard, Piute, San Juan, Sanpete, Sevier, Utah, and Wayne Counties.
- d. **Local Boards of Education.** Members of the local boards of education should be elected as determined by individual school boards or districts.

3. JUDICIAL

- a. **Supreme Court.** There will be an unopposed retention election for one (1) Supreme Court Judge, provided that the incumbent whose term is expiring files during the filing period.
- b. **Court of Appeals.** There will be an unopposed retention election for one (1) Court of Appeals Judge, provided that the incumbent whose term is expiring files during the filing period.
- c. **District Court.** There will be a retention election for twenty-four (24) District Court Judges in the following districts, provided that the incumbent(s) whose term is expiring files during the filing period:
 - i. **First District.** Two (2) Judges in the First Judicial District, which consists of Box Elder, Cache, and Rich Counties.
 - ii. **Second District.** Four (4) Judges in the Second Judicial District, which consists of Davis, Morgan, and Weber Counties.
 - iii. **Third District.** Nine (9) Judges in the Third Judicial District, which consists of Salt Lake, Summit, and Tooele Counties.
 - iv. **Fourth District.** Four (4) Judges in the Fourth Judicial District, which consists of Juab, Millard, Utah, and Wasatch Counties.
 - v. **Fifth District.** Three (3) Judges in the Fifth Judicial District, which consists of Beaver, Iron, and Washington Counties.
 - vi. **Sixth District.** One (1) Judge in the Sixth Judicial District, which consists of Garfield, Kane, Piute, Sanpete, Sevier, and Wayne Counties.
 - vii. **Eighth District.** One (1) Judge in the Eighth Judicial District, which consists of Daggett, Duchesne, and Uintah Counties.
- d. **Juvenile Court.** There will be a retention election for ten (10) Juvenile Court Judges in the following districts, provided that the incumbent(s) whose term is expiring files during the filing period:
 - i. **First District.** One (1) judge in the First Judicial District, which consists of Box Elder, Cache, and Rich Counties.
 - ii. **Second District.** Two (2) Judges in the Second Judicial District, which consists of Davis, Morgan, and Weber Counties.

- iii. Third District. Three (3) Judges in the Third Judicial District, which consists of Salt Lake, Summit, and Tooele Counties.
- iv. Fourth District. Two (2) Judges in the Fourth Judicial District, which consists of Juab, Millard, Utah, and Wasatch Counties.
- v. Fifth District. Two (2) Judges in the Fifth Judicial District, which consists of Beaver, Iron, and Washington Counties.

e. **Justice Court.** Any Justice Court judge whose term is expiring shall be subject to an unopposed retention election in the county or counties in which the court to which the judge is appointed is located.

4. **COUNTY**

County offices up for election are to be determined by the county's form of government.
