PROPOSITION NO. 5
Annual Sessions of the Legislature
 Shall Sections 2 and 16 of Article VI of the Constitution of the State of Utah be amended to provide for annual sessions of the Legislature consisting of a General Session of not to exceed forty-five legislative days in odd numbered years and a Budget Session of not to exceed twenty legislative days in even numbered years. This proposal would replace a sixty calendar day session which now meets every other year.

PROPOSITION NO. 6
Convening of Special Session of Legislature By Legislature Itself
 Shall a new Section be added to Article VI of the Constitution of the State of Utah to authorize the Legislature to call itself into Special Session upon the written request of two-thirds of the members of each House.

PROPOSITION NO. 7
Legislative Compensation and Expenses
 Shall Article 9 of Article VI of the Constitution of the State of Utah be amended to provide that members of the Legislature receive a salary for their services in the amount of One Thousand Dollars per year, unless otherwise provided by law, and receive an allowance for expenses and mileage, as fixed by law when attending committee meetings of the Legislature held between sessions and when otherwise engaged in official business.

PROPOSITION NO. 8
Board of Examiners Amendment
 Shall Section 13 of Article VII of the Constitution of the State of Utah be amended to abolish the Board of Examiners, which is comprised of the Governor, the Secretary of State and the Attorney General. This Board now has the duty to examine all claims against the State of Utah and to perform such other duties as are prescribed by law.
